Criminal Record Extract

The scope of the information varies from one recipient to another in accordance with the Law.

Criminal Record

Clarifications:

- In an appeal, a retrial or a presidential decision to mitigate a sentence, only the decision given in that proceeding is presented. Details of the previous instances are presented; however, the judgments rendered in them are not.
- Where a judgment is varied in the course of the revocation or extension of a probation order, the revocation of a community service order, the substitution of a measure imposed on a minor, the trial of a defendant who has become fit to stand trial, or a presidential decision to mitigate a sentence, the judgments given in the previous instances are also presented.
- In the revocation or extension of a probation order or a community service order, only the offenses dealt with in the revocation proceeding and the penalties imposed in place of probation or community service are presented. Decisions and penalties for offenses not dealt with in the revocation proceeding are presented only under the previous proceeding.

- d. The limitation and expungement dates under the Law are presented alongside each conviction or other court decision; they are calculated as of the date on which the information is produced and may change if further convictions or court decisions are added.
- e. The criminal record regarding corporations is partial. It includes information on corporations from 1.1.2014, except for cases involving offenses under the Planning and Building Law and the environmental protection laws, in respect of which the criminal record includes information from 1.1.2007.
- f. With regard to the scope of information, section 16 of the Law stipulates that once the expungement period has elapsed, the conviction shall be deemed expunged and no information about it shall be provided, except to the bodies listed in items (b) to (e) of the First Schedule and to the Attorney General.
