Whereas: No person knows the day of his death;

And Whereas: I wish to make a Will and to express my last wishes regarding everything that shall be done with my property after my death, after a long life;

And Whereas: I am over eighteen years of age, a citizen of Israel and a resident of the State of Israel;

Therefore, I, the undersigned, [REDACTED], ID No. [REDACTED], of [REDACTED], [REDACTED], being of sound mind and fully capable of understanding the nature of a Will, and at my own discretion, hereby bequeath with a settled mind and without any undue influence on me by any party, as follows:

Property

My property in this Will shall be construed as my property and assets of every kind and type whatsoever, wherever located, whether in Israel or abroad, including movable and immovable property, and including my apartment at [REDACTED] in the city of [REDACTED], shares, cars, foreign currency, savings plans, bonds, monies, current accounts, whether in my possession or held as a deposit, as well as rights of any kind whatsoever, and any money and any relevant item, as they shall be on the day of my death.

Distribution of the Property:

I direct that after my death all my property, as it shall be on the day of my death, shall be collected; all my debts until the day of my death to the governmental authorities, to the authorities and to any other person and entity shall be paid; the burial and tombstone expenses, the funeral and the estate administration expenses shall be paid; and my property shall be distributed as detailed below:

I hereby bequeath **all of my property in its entirety**, wherever it may be, to my granddaughter Dr. [REDACTED], ID No. [REDACTED], born on [REDACTED].

This Will of mine is made without any influence by any person whatsoever and after much thought, and the reason that I do not bequeath anything to any of my children is that I wish to bequeath all of my property, wherever it may be, solely and exclusively to my dear granddaughter Dr. [REDACTED]. I direct that if any person claims any right whatsoever in my property, or if any person files an objection to this Will of mine, the Family Court is requested to dismiss such objection, since this Will of mine was made while I was conscious and of sound mind, out of my own independent thought and without any influence of any person whatsoever, and **I have also requested that this Will of mine be documented by photograph and video for the purpose of proving my capacity.**
